HOW TO CAST YOUR VOTE WITH MICROVOTE INFINITY

Note: This is a sample Ballot and arrows may not line up as they do on the actual voting unit.

3. Push the button next to the candidate of your choice. An "X" will appear in the box next to the candidates name. If you wish to change your choice press the button again, and it will cancel your selection. You may then continue voting.

4. Press NEXT PAGE to Advance the ballot and PRIOR PAGE to go back to Review your ballot. These are the bottom Left and Right buttons.

5. If you wish to cast a Write-In Vote, press the Write-In button at the office you are voting for. The Write-in screen will appear. Push the buttons next to the desired letters to spell the candidate's name. This name will appear on the center of the screen. Use the SPACE or ERASE button to advance or re-type the candidates name. Press the DONE button at the bottom right to Accept and return to the ballot.
